- Under 3, Membership, replace the existing wording of Clause c) "Subscriptions shall be paid on acceptance of an application for membership and subsequently on 1st January each year" with "Subscriptions shall be paid annually on acceptance of an application for membership".
- Under 4, Management, in Clause a) after "The administration of the Society shall be vested in a Committee" insert "(the Society's Trustees)".
- Under 4, Management, in Clause b) replace "Chairman" with "Chair".
